Privacy Notice

(Pursuant to Article 13 of the European Regulation No. 679/2016)

Before acquiring your personal data for registration to the lost items search service at Naples International Airport, Gesac Spa invites you to carefully read the privacy notice regarding personal data protection.

I. Data Controller and DPO

Data Controller: Società Gestione Servizi Aeroporti Campani S.p.A., with registered office in Naples (80144), Capodichino Airport, "GESAC" Executive Offices s.n.c., tax code and VAT number 03166090633, registered with the Companies Register of Naples (R.E.A. n. NA-324314), represented by Barbieri Roberto, in his capacity as Chief Executive Officer and Delegate for the Exercise of Data Controller Powers, domiciled for the position at the company's headquarters ("GE.S.A.C").

II. Types of Personal Data

- **Data acquired directly from the data subject:** Personal data: (name, surname, residential address), contact details (email, telephone contacts).
- **Data acquired automatically during browsing:** IP address, type of browser used, ISP, information about the pages visited within the site, access time, time spent on each page.
- The aforementioned data will be processed using electronic and paper-based means to ensure suitable security and confidentiality measures.

III. Purpose of Processing

Management of the procedure; Nature of provision (Mandatory); Legal basis (Contractual).

The provision of data necessary to achieve the aforementioned purposes is "**mandatory**" and any refusal thereof results in Gesac S.p.A.'s inability to process the request for retrieval of lost items.

IV. Data Recipients

For the pursuit of the aforementioned purposes, personal data will be processed by the following entities.

Entities affiliated with Gesac S.p.A.:

- Employees operating at Naples International Airport - Capodichino;
- Collaborators and suppliers of GESAC

Entities not directly affiliated with Gesac S.p.A.:

- FindMyLost (as Independent Data Controller) with registered office at Via Arena, 25 - 20123 Milan, VAT and Tax Code: 0940589096
- Judicial authorities
- Public security authorities

Your data will only be processed by entities expressly authorized by Gesac S.p.A. or by companies acting as **Data Processors** on behalf of Gesac S.p.A., which have entered into a specific contract that regulates in detail the processing entrusted to them and the obligations regarding data protection and will never be disclosed.

V. Data Retention

The personal data you have provided for the purposes outlined in paragraph III will be retained for the time necessary to manage the process of searching/retrieving lost items and subsequently destroyed, except for further retention for the management of any claims or to comply with specific requests from the judicial authority, adopting suitable measures to ensure the security and confidentiality of the data.

VI. Rights of the Data Subjects

EU Regulation 2016/679 (Articles 15 to 23) grants specific rights to data subjects. Concerning the processing of your personal data, you have the right to request from Gesac S.p.A., access, rectification, erasure, restriction, objection, and portability; furthermore, you can lodge a complaint with the Supervisory Authority, which in Italy is the Data Protection Authority.
